### **Mandatory Requirements For Bidders**

The following **must** be submitted together with the bid;

1. **Certified** copy of Certificate of **Incorporation/Registration**,
2. **Certified** copy of **Valid** Registration Certificate with the National Construction Authority in the classes specified in the tender notice
3. VAT and PIN Registration from **KRA**,
4. A copy of **Valid** Tax Compliance Certificate from **Kenya Revenue Authority (KRA)**,
5. **Certified** copy of **Recent** CR12 FORM (**WITHIN 12 MONTHS**) from registrar of companies.
6. **Certified** copy of Single Business Permit preferably from **Kisumu County**.
7. Bidders shall sequentially serialize all pages for each tender document submitted failure to which the bidder shall be disqualified.
8. **Bid bond - 2%** of the Tender Sum.
9. **Certification must be by a commissioner for oaths.**

### **OTHER REQUIREMENTS**

As specified in the Tender Documents, Bidders should submit documentary evidence covering the following:

1. Eligibility.
2. Similar previous experience.
3. Current workload.
4. Professional and technical personnel.
5. Audited financial statements for the last three years (**2015 - 2017**) provided.
6. Litigation history (**Current Sworn Affidavit**).
7. Any form of canvassing will lead to automatic disqualification.
