- 5) Copy Certificate of Registration with relevant regulatory bodies.
- 6) Business/Company Profile.

The applicant MUST also demonstrate:

- Existence for the last 5 years in relevant field
- Willingness and ability to work with County Government of Kisumu
- The necessary Technical skills and experience to manage and deliver the assignment Sound financial management capacity
- The applicant must have no history of legal proceedings' related to fraud or corruption and demonstrate that they are not insolvent, in receivership or bankrupt.
- Proof of similar work done.
- Audited financial statements for the last three years (2015 – 2017) provided. Companies registered within the last one year should submit certified bank statements for at least twelve months or the duration of registration
- Litigation history or Current Sworn Affidavit.
- Necessary qualification, capability, experience, resources, equipment and facilities to provide what is being procured
- Legal capacity to enter into contract for the procurement
